Grizzly Recovery Decision Near?



ast spring grizzly advocates were thrilled to learn that the National Park Service (NPS) and U.S. Fish and Wildlife Service (USFWS) intended to finalize their grizzly bear recovery plan for Washington's North Cascades as soon as this fall.

Sadly, we have been surprised to learn that the effort is delayed as of this writing due to opposition from Representative Dan Newhouse (R-Yakima). To continue moving the effort forward, please contact Senator Maria Cantwell, ranking member on the Senate Energy Committee at (202) 224-3441 and encourage her to ask NPS and USFWS to continue their work to recover the grizzly. You can call your House representative with the same request.

Despite this recent hurdle, the momentum in favor of grizzly restoration in the Northwest continues to build. The Yakima Herald editorial board endorsed grizzly recovery in July, and letters from supporters continue to appear in local newspapers, applauding the agencies' move to restore the "Great Bear."

Now that the federal agencies may add bears to the existing population in the North Cascades, they must consider the best way to manage bears who roam outside of the recovery zone or misbehave. Department of the Interior Secretary Ryan Zinke ordered USFWS to consider labeling the population "experimental" to allow wildlife managers the flexibility they need to effectively respond to the "problem" bears. NPCA, while acknowledging the need for some management flexibility, will stay vigilant to ensure the plan works for the bears, too.

Thank You, Congressman Reichert

or those of us hustling to keep pace on the trail behind him, his pause at the Alpine Lakes Wilderness sign was a welcome break.

"This is what I did for you boys," he said, looking at his two grandsons with a beaming smile.

Rep. Dave Reichert can be rightfully proud of championing legislation to save this area and many other conservation votes during seven congressional terms.

His district stretches from Auburn to Wenatchee and includes much of North Cascades and Mount Rainier National Parks.

Though the politics for protecting wilderness and parks are favorable here, Dave always seems even more personally invested. He's been the Republican co-chair of the House National Parks Caucus for years, and he's stood up to his party's leadership to protect wildlands,

national monuments and to prevent oil drilling off Washington's coast. Dave is also a prime cosponsor of the Restore Our Parks Act which would fund the backlog of repairs plaguing the parks.

It's out here on the trail in "the other Washington" where his true motivation shows. He simply likes these places, and he wants his grandchildren to have these experiences, too.

We'll miss Dave Reichert's strong conservation voice after he retires in December, and we hope his successor will keep

this work going. Meanwhile, thank you, Congressman Reichert, for your commitment to the national parks and the outdoors!

UPDATES FROM AROUND THE NORTHWEST

#FIXOURPARKS - FOR THE ECONOMY! - National parks face over \$11.6 billion in "deferred maintenance," the term for longstanding repair needs that haven't been addressed due to inadequate funding. Crater Lake National Park alone needs over \$94 million to repair roads, buildings, trails and more. Underfunding doesn't make sense when we consider that parks are economic engines for their communities. Last year, visitors to Crater Lake contributed nearly \$60 million in spending to the Oregon economy, which in turn created 981 jobs.


