Campaign Updates

Fight for Jamestown Continues

Our fight continues to protect Jamestown and the James River in Virginia from Dominion Energy's oversized electric transmission line. In May 2018, the U.S. District Court for the District of Columbia ruled against us in our legal challenge to the U.S. Army Corps of Engineers' approval of a key permit. In early December, the U.S. Court of Appeals for the D.C. Circuit heard oral argument in our appeal of the lower court's ruling, and at press time we await the result. We are evaluating legal options against the Corps and the National Marine Fisheries Service for related Endangered Species Act violations.

Preparing for our Next 100 Years!

ay 19, 2019 marks NPCA's 100th birthday. We have ambitious plans to celebrate this remarkable milestone, from exciting events with partners to increasing our advocacy capacity to centennial-related messaging throughout the year. We're proud of our ten decades as the only independent, nonpartisan organization advocating on behalf of America's national parks! In addition, our centennial year provides an opportunity to take stock—to look back on where we've been and to chart a course for where we'd like to go, with the help of supporters like you.

As we reflect on some of the important park highlights from the last 100 years, a few of the critical park victories NPCA has helped secure in the Mid-Atlantic region include:

- Securing funding to preserve key lands and protect clean water throughout our region.
- Protecting existing national parks from multiple incompatible proposed developments, including at Gettysburg and Fredericksburg & Spotsylvania National Military Parks, at Harpers Ferry and Valley Forge National Historical

Parks, at New River Gorge National River and at Petersburg National Battlefield.

- Reducing harmful air pollution at dozens of parks, including Shenandoah National Park, thereby benefiting the health of park visitors and nearby communities.
- Establishing new national parks that help tell untold or under-told stories of America's collective journey towards a more perfect union. Our efforts include the establishment of Fort Monroe National Monument, where slavery began—and began to end—in America; Belmont-Paul Women's Equality National Monument, which

Fight for Manassas Battlefield Marks Initial Success

In 2017, the Virginia Department of Transportation (VDOT) announced plans to add traffic lanes to I-66 in an area next to Manassas National Battlefield. After the National Park Service agreed to the plans, VDOT changed them by adding two tolled elevated access ramps that would be visible from the battlefield.

NPCA has spearheaded a coalition that successfully persuaded VDOT to move one ramp away from the park's viewshed and to reduce the harsh visual impacts of the second ramp. We continue to advocate for VDOT to minimize the visual and auditory impacts the new traffic ramp would have on this historic battlefield.

commemorates the successful campaign for women's suffrage and the continuing campaign for equal pay for equal work; First State National Historical Park, which offers opportunities to delve into European colonization and eastern Indian tribes; and Harriet Tubman Underground Railroad National Historical Park, one of a handful of parks dedicated to the story of a female American hero.

Preserving additional historic lands at existing parks by expanding the park boundary at parks like Gettysburg National Military Park, Harpers Ferry National Historical Park, and Petersburg National Battlefield.

We look forward to our next 100 years of engaging and inspiring the next generation of park advocates, protecting and enjoying our most beautiful places, and embracing

Please Help Fix Our Parks!

he value of national parks as America's "common ground" is reflected in an extraordinary bipartisan effort to secure federal funding to address the highest

priority projects on the National Park Service's long list of overdue repairs.

At press time, NPCA and our partners in the Second Century Action Coalition are urging House and Senate leadership to approve bills to provide \$6.5 billion over five years for the Park Service to replace roofs on historic buildings, rebuild trails, upgrade failing water and sewage systems, and tackle other high-priority projects.

S. 3172, introduced by Senators Rob Portman (R-Ohio), Mark Warner (D-Virginia) and Angus King (I-Maine), has 34 cosponsors. The companion bill H.R. 6510, introduced by Reps. Rob Bishop (R-Utah) and Raul Grijalva (D-Arizona), has 227 cosponsors. The effort also has the support of Interior Secretary Ryan Zinke and the Trump administration.

Then, ask each of them to do everything possible to get this legislation over the finish line in the closing days of the 115th Congress.
